### **Sirma Group Holding Overview**

Sirma's group consist of 12 subsidiaries (4 first tier and 8 second tier), 3 associated companies and 3 consortiums.

Where the ownership is less than 100%, it is split among different individuals, employees of the group. The only exception is Ontotext, where 40% are held by a private equity fund, called NEVEQ. Each company is specialized in a specific field and has its own stuff. Apart from management, SGH provides administrative, financial and marketing services on a group level.

Several companies have their registered seat outside Bulgaria to help increase the reach and brand awareness of Sirma. They focus on the USA, Brazil and the UK.

Targeting a removal of some ineffective parts, a group restructuring took place in October 2014 (already reflected in the graph).

Two companies (Pirina Technology AD & Sirma Media AD) were drawn out of the group structure. The share capital was decreased by 23.5 million shares to its current size of 49.8 million shares.






